AT&T subscribes to and supports the American Registry for Internet Numbers (ARIN) guidelines set forth in RFC2050 and retains ownership of any network numbers assigned to it's customers. Customers leaving the AT&T DSL network will be required to stop using the network numbers assigned from AT&T DSL Internet Service address space.

DSL Internet Service (multi-user only) offers IP addressing options providing a maximum of 5, 13, or 29 public IP addresses. AT&T will evaluate the reason for needing these IP addresses before authorizing the assignment.

NOTE: If you do not need public IP addressing, and can use Network Address Translation with priviate IP addresses, please do not continue with this form. Contact a SelectNet representative about your order.
